### **1. Introduction and Context**

Rogiet Community Council (RCC) serves the communities of Rogiet, Llanfihangel and Common-y-coed — an area combining a populated village and surrounding rural landscapes.

- Population: 1,790 (2021 Census)
- 2025/26 Precept: £71,500

#### **Key Assets:**

Community playing fields (Football Pitch, MUGA, and Sports Pavilion), Small Play Park that is owned and maintained by Monmouthshire County Council (MCC), a public footpath and lane and support for Rogiet Countryside Park.

Rogiet's history is closely linked to the railway industry particularly the construction of the Severn Tunnel around which the village developed. The area contains varied habitats including woodlands, open fields, hedgerows and the nearby Gwent Levels and Severn Estuary which are rich in biodiversity.

Other areas of note in the Rogiet and Llanfihangel Rogiet areas are woodland and fields owned by other organisations such as the Woodland Trust and Gwent Wildlife Trust. Public footpaths run along many of these areas, past the remains of the Rogiet Windmill, around Ifton Quarry to the north of Rogiet, and the Wales Coastal Footpath at the sea wall to the south, overlooking the Severn Estuary and traversing the Gwent Levels.

The area, in particular the main village of Rogiet and the neighbouring hamlet of Llanfihangel Rogiet is affected by pollution (air quality and noise) from the busy B4245 which runs through them and from the M4 and M48 motorways (the main routes between Wales and England via the Prince of Wales Bridge and the Severn Bridge respectively), which pass either side. The main Swansea to London railway line also passes in close proximity to the village of Rogiet.
