Council discussed at length the most suitable materials for repairing the potholes on Ifton Lane and considered the quotes provided.</p> <p>Council approved the quote from DJS Civil Engineering for stonedust only, at a cost of £450.00 + VAT. Council agreed to monitor the condition of the lane over the forthcoming year.</p> <p>Council further agreed to request a 50% contribution from NGM as their business is considered to have contributed the most to the damage and deterioration of the lane and their business uses Ifton Lane daily with parked</p> |
